Chinook Trail Association has applied for funds from SWIFT to assist in purchasing some equipment to split boulders. The two pieces of equipment are a "Boulder Buster" and a rock drill. These two carry a big price tag in excess of \$10,000, but make light work out of removing those huge boulders which block the paths of many trail projects. If funded this carries a 50-50 match obligation for CTA.

CTA Represented at Federation of Western Outdoor Clubs

When the Federation of Western Outdoor Clubs met in Redding, California, August 25-26, I had the privilege of representing Chinook Trail Association. For a day and a half, we heard panel discussions on various hot outdoor topics, including:

- saving desert tortoises from habitat destruction by an expanding Army training grounds;
- use of fire in reducing catastrophic fires in the forests;
- an update of the Sequoia National Monument controversy.

The annual meeting was at Simpson College, where the 34 attendees were housed in dorms and ate in the cafeteria — pretty good for college fare.

The third day we spent on FWOC business including election of officers, voting on 28 resolutions submitted by the member clubs, and budget considerations. Former Sierra Club president Mike McCloskey was elected president of FWOC, replacing Brock Evans. I was CTA's voting delegate and was

re-elected to serve as FWOC vice president for Southwest Washington for a second year. Each Western state has a few regional vice presidents.

As a point of clarification, delegates vote on the resolutions and FWOC forwards those supported by the membership to our national committee in Washington, D.C. The national committee lobbies Congress and the President to support and act on these resolutions.

Next year's meeting will tentatively be in Vancouver, B.C., to be hosted by the Sierra Club chapter from Victoria.

National Recreation Trails Funding Act

Chinook Trail Association's trail renovation grant application for the year 2000 has been rated in the top eight best projects of 40 submitted by agencies and organizations from throughout the State of Washington by an impartial Interagency for Outdoor Recreation evaluation team.

This is good news as the total grant request was for \$31,000 to renovate the trails of Hamilton Mountain, Hardy Creek, steps and bridge crossing of Hardy Creek. Figuring prominently in the grant features was the prevention of siltation of Hardy Creek, a chum salmon spawning stream.

Assignment of funding was to be announced in September and every indication is the Hamilton Mountain project would be funded. If funded, work can begin in 2001. This carries with it an obligation from CTA of \$6,500 and Washington State Parks of \$11,000 in cash and volunteer work. The IAC-administered funds for this project will come from federal National Recreation Trails Program dollars.




CTA provided the food, menu planning, cooking gear, tools and supervision. State Parks provided the group camp. Participants were given T-shirts, mugs and trail patches.

The Bells Mountain trail project continues to be stalled and bogged down in paperwork and permit applications. CTA is being told by the county that they expect the permits to arrive soon, but we have been strung along for three years now with no end in sight.

The latest boondoggle is that the Army Corps of Engineers has reviewed the SEPA application and they now want a biological assessment of the project. As of this writing, the B.A. has been completed and is awaiting review by the Corps. With the projected backlog of permit applications; the Corps may take up to 18 months before getting to our project, but we won't know until they actually make a ruling.

The worst case scenario is that CTA may have to reroute the trail in some areas. Hopefully the Corps will be satisfied with the trail as is.

In January, Stimson Timber Co. rejected a proposal to move the trail out of the Cedar Creek riparian area to a location farther into their property, so we surveyed another route which Department of Natural Resources eventually sent to Stimson on July 6, 2000. As of September 10th, there has been no response.

The new 4(d) rules of the Endangered Species Act became effective on September 9, which may further complicate and restrict our trail and bridge project, but we need to further review this.

Unfortunately, there is not much good news about the Bells Mountain Trail this time around, but time has a way of sorting things out. In the mean time, we will continue to press the county and DNR for a resolution to the problems we face.




