These closing remarks of my address at the annual meeting refer to our need to hire an Executive Director so that we can move forward with our vision of a trail around the Gorge at a faster and steadier pace. After I concluded, our keynote speaker Glenn Lamb, Executive Director of the Columbia Land Trust, issued a challenge to us to raise enough capital and to designate a special fund for a grant writer, who will then write a grant to fund the position for an Executive Director. His goal was to raise \$10,000 in checks and pledges that very afternoon as seed money for such a venture. Glenn donated a check for \$500 and pledged another \$500. We fell short of his goal by less than \$3000, and since then additional gifts have made up some of that short fall. We need about \$2000 to complete this goal. We call this the Trailblazer 2001 Fund.

This is an important step forward for us as we have come to a critical time in the life of CTA. We MUST take this step if we are to survive and prosper. Your help is needed and will be greatly appreciated. Enclosed in this newsletter is an envelope for your donation to this milestone effort. Thank you for your continued support.

SWIFT Grant Awarded


SWIFT has awarded a \$2,500 grant to Chinook Trail Association. The purpose of the grant is to assist CTA in purchasing a Boulder Buster. The Boulder Buster is a device used to split apart boulders that are too large to be broken up

by hand tools or moved by hand.
This tool will be very helpful in
building trails and in removing
boulders, as will need to be done in
the Silver Star area due to
landslides.

This grant requires a like

amount of match by CTA. Anyone wishing to make a special contribution to assist with this purchase will be duly recognized by having the first blasts from this device detonated in honor of him or her. Donors will be invited to a special blast off ceremony.

Alternative Spring Break

The Chinock Trail Association has already been busy this season as we hosted and led two week-long work parties with students from Reed College and Lewis and Clark College. The students from these schools volunteered with CTA during their spring break, a coveted time for any college student. They worked on the Hamilton Mountain Trail in Beacon Rock State Park and spent their nights in the group camp. As their friends frolicked on the warm, sunny, sandy coasts of California and Mexico, these students enjoyed the beauty and comfort that only the rains of the Northwest can bring. These groups accomplished much during their time on the trail. A retaining wall was replaced and gravel filled in on the approach to the first bridge out of the picnic area, and a fence was installed near the waterfall. The students also performed some general maintenance on the trail, such as filling in problem spots with gravel and cleaning out clogged water bars. Chinook Trail Association is very appreciative of the work that was accomplished and thanks the students and colleges for the time and service they donated.

Bells Mountain Trail Update by Roger Anderson

Here we are in the new year and still in the "wait and see" mode. Not much progress has been made since the previous report in October of last year.

You may recall that the US Army Corps of Engineers required a biological assessment of the Bells Mountain Trail corridor to identify any possible critical habitats and to examine our treatment of water crossings. The Corps is reviewing the assessment now. After a question was raised concerning culverts vs. bridges for three crossings, CTA will upgrade to short bridges to expedite and satisfy the Corps' concern. We should be given the green light to go ahead and finish the trail if there are no critical habitat issues after the review has been completed.

Remember, there are 42 water crossings in the 7.5 miles of trail, so a full steam go ahead signal would be a major step.

The State Department of Natural Resources is proceeding with their timber sale across our trail immediately south of the

Moulton Falls Park Boundary. It is scheduled for this Spring and the highest bidder will have two years to log the unit once the contract has been awarded. There will be some impact on the trail corridor, but the contractor is required to restore the damaged section of trail to its original condition.

As you can see, there are many issues revolving around the completion of the Bells Mountain Trail. It has been a four year effort with the agencies involved, further stymied and convoluted by new environmental regulations to be met each year. CTA in cooperation with the agencies is finally beginning to pull through the mire of red tape; now we will need a lot of helping hands to complete the culverts, bridges, and trail segments remaining.

Hamilton Mountain SEPA Moves Forward by Don Cannard

Ever watch a snail move through your garden? It about equals the speed with which SEPA documents move through the system on their way to approval. We are progressing slowly but steadily on the Hamilton Mountain Restoration Project. We have met with most of the individuals having jurisdiction over this project and any future trail projects in the vicinity.

This project will improve some

failing steps on the Hardy Creek crossing, replace over 20 switchbacks with just one, improve the trail to Little Beacon Rock Overlook, replace railings and kickrails on the Hardy Creek bridge, and add some nice viewpoints. The SEPA report also addresses the planned improvement of the trail coming out of the campground area to a barrier free ADA status.

Estuary Grant

Chinook Trail Association has received a grant from the Lower Columbia River Estuary Program to provide plants and fencing to protect steep slopes around the Hardy Creek crossing. This grant will make it possible for CTA to provide more soil protection in order to eliminate the erosion that leads to sediments finding their way into Hardy Creek. Hardy Creek is one of two of the vital spawning streams below Bonneville Dam for the Chum Salmon.
